

**Public Notice of Rights under Title VI**

In keeping with the City's Values of Diversity and Unity, La Mirada Transit Services is committed to ensuring that **no person is excluded from participation in, or denied the benefits of its service on the basis of race, color or national origin** as provided under Title VI of the Civil Rights Act. In addition, La Mirada prohibits discrimination based on religion, gender, gender expression, age, disability, marital status, sexual orientation, or military status, and other protected classes enumerated in federal and state laws.

La Mirada Transit Services promotes full and fair participation of all potentially affected populations in transportation planning and decision making, including providing meaningful access to La Mirada Transit services by persons with limited English proficiency.

**Title VI Complaints**

If you believe you have been discriminated against, you must file a signed, written complaint within 180 days of the date of alleged discrimination. The complaint should include the following information:

- Your name, address, and how to contact you (i.e., telephone number, email address, etc.)
- How, when, where, and why you believe you were discriminated against. Include the location, names, and contact information of any witnesses.
