**NOTICE IS HEREBY GIVEN** of a public hearing to be held by the Planning Commission of the City of La Mirada on **Thursday, June 15, 2017, at 6:30 p.m.** in the City Hall Council Chambers located at 13700 La Mirada Boulevard, La Mirada, California to consider the following:

**CONDITIONAL USE PERMIT NO. 318: A REQUEST TO REPLACE THE EXISTING CUPOLA HOUSING A ROOF MOUNTED WIRELESS FACILITY WITH A NEWLY DESIGNED CUPOLA. CHANGES TO THE WIRELESS EQUIPMENT ARE NOT PROPOSED. THE SUBJECT SITE IS LOCATED AT 13701 HILLSBOROUGH DRIVE, WITHIN THE PLANNED UNIT DEVELOPMENT (PUD) ZONING DISTRICT.**

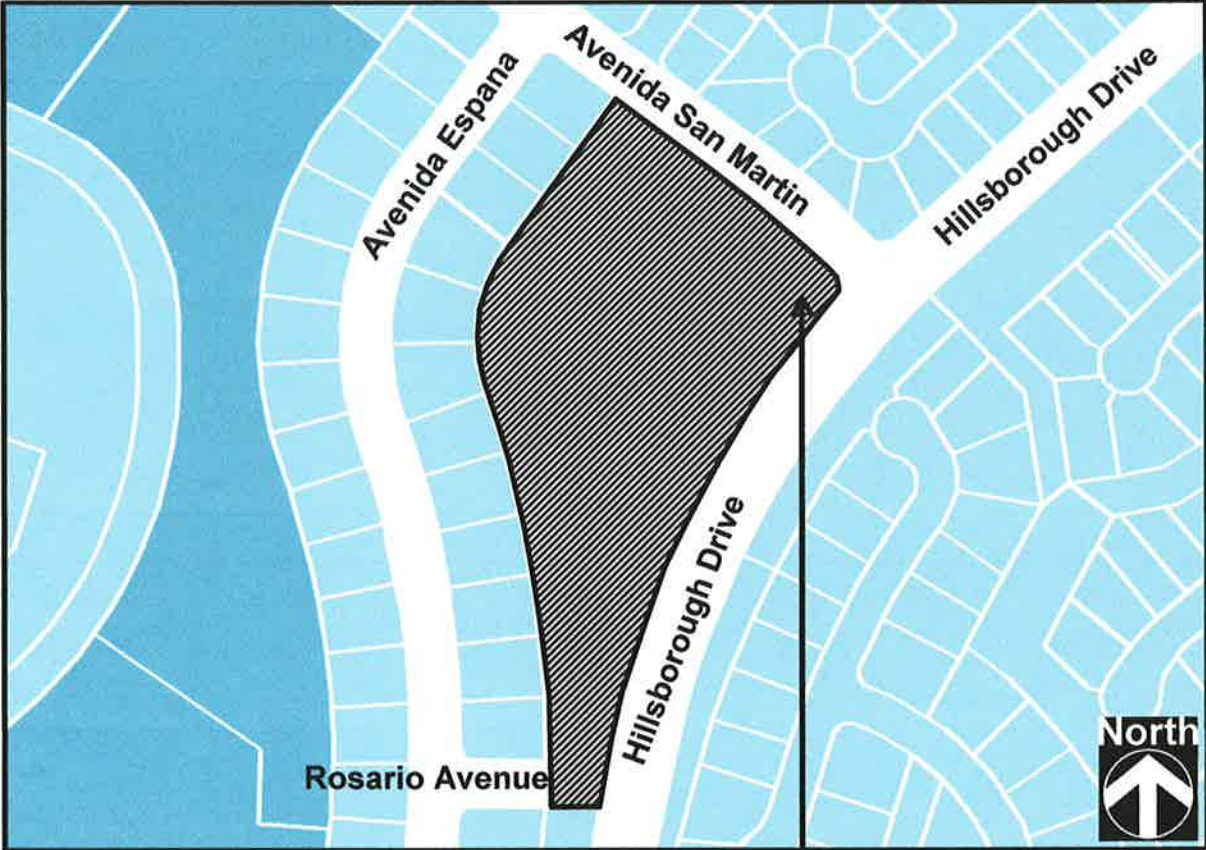
