The City Council found that pursuant to the California Environmental Quality Act of 1970, the project is categorically exempt under Section 15301 Class 1 (a) and will have no significant effect on the environment; approved the plans and specifications for Capital Improvement Project No. 2016-14, Sheriff's Station Emergency Generator Connection; and authorized the City Clerk to advertise for sealed bids.

- 9. PUBLIC HEARING
 - 9.1 ORDINANCE NO. 700 APPROVING ZONING ORDINANCE 47 AND RELATED MUNICIPAL AMENDMENT NO. CODE AMENDMENTS, PROHIBITING ALL MEDICAL AND NON-MEDICAL COMMERCIAL CANNABIS ACTIVITY, PROHIBITING OUTDOOR CULTIVATION, AND REGULATING INDOOR CANNABIS CULTIVATION, CONSISTENT WITH STATE LAW

Mayor Eng opened the Public Hearing.

No members of the public spoke on the item.

City Planner Gabriel Bautista presented a report on the proposed ordinance. He said Ordinances No.'s 677-U, 679-U, 685-U, 686-U and 687-U were adopted to provide the City with immediate protection from the

potential establishment of marijuana/cannabis businesses, uses and activities. He said the State of California has been analyzing the legislative changes. He said as a result, on June 27, the Governor signed into law Senate Bill 94 which repealed the MCRSA, included certain provisions of the MCRSA in the licensing provisions of the AUMA, and created a single regulatory process for medical and non-medical cannabis known as the Medicinal and Adult-Use Cannabis Regulation and Safety Act ("MAUCRSA"). He said the ordinance under consideration proposes to add a new Chapter 9.132, "Cannabis Prohibition and Regulations," to Title 9 of the LMMC. Additionally, the new chapter would establish definitions for certain terms, list prohibited activities, and list exceptions and penalties for violations of these regulations.

Mayor Eng closed the Public Hearing.

Mayor Pro Tem Mowles moved and Councilmember Lewis seconded to affirm the CEQA Exemption; and introduce for first reading Ordinance No. 700 adding a new Chapter 9.132, "Cannabis Prohibition and Regulations," to Title 9 of the LMMC; repealing Chapter 21.48 "Medical Marijuana Dispensaries," of Title 21 of the LMMC; and adding a new Chapter 21.48 "Commercial Cannabis and Cultivation" to title 21 of the LMMC, consistent with state law, by title only, and waive further reading.

 - 10.1 RESOLUTION NO. 17-31 AUTHORIZING THE USE OF SENATE BILL 1 (SB 1) ROAD REPAIR AND ACCOUNTABILITY ACT (ACT) FOR FISCAL YEAR 2017-18

City Manager Boynton provided information on Resolution No. 17-31. He said the Alondra Boulevard and Phoebe Avenue traffic signal project has been identified as a project eligible for the use of SB 1 funds. He said the intersection has heavy truck volumes and extended delays for vehicles entering Alondra Boulevard. He said work would include the installation of handicap ramps on all four corners and improved intersection lighting with high efficient LED overhead lights. The project would enhance safety and

reduce delays for vehicles entering Alondra Boulevard from Phoebe Avenue.

City Manager Boynton said the project design has progressed and the estimated completion would be December 2017. He said the construction would be completed by next summer.

Councilmember Lewis moved and Mayor Pro Tem Mowles seconded to adopt Resolution No. 17-31 authorizing the use of Senate Bill 1 (SB 1) Road Repair and Accountability Act for Fiscal Year 2017-18 and authorizing staff to submit the project list to the California Transportation Commission.

10.2. RESOLUTION NO. 17-32 APPROVING THE APPLICATION FOR TRANSIT AND TRANSPORTATION FUNDS FOR FISCAL YEAR 2017-18

She said for Fiscal Year 2017-18, the City of La Mirada would be applying for a total of \$3,220,391 from local and state funding sources.
