CITY OF LA MIRADA NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN of a public hearing to be held by the Planning Commission of the City of La Mirada on **Thursday, December 21, 2017**, **at 6:30 p.m.** in the City Hall Council Chambers located at 13700 La Mirada Boulevard, La Mirada, California, to consider the following:

CONDITIONAL USE PERMIT NO. 320 AND VARIANCE NO. 165: A request to construct and operate a fast food restaurant with a drive-through aisle and reduce the required rear yard setback, reduce the landscaping requirement, and allow for one (1) additional monument sign at the northeast corner of Imperial Highway and Santa Gertrudes Avenue at 15809 Imperial Highway, within Planning Area 3C (PA-3C) of the Imperial Highway Specific Plan (IHSP) Zoning District.

At the hearing, the Planning Commission will consider staff's report and recommendation, as well as all testimony and public input, prior to making a final decision. The documents being considered are available for review at the City's Community Development Department office located at City Hall, 13700 La Mirada Boulevard, La Mirada, California. 
