# 6. TRAFFIC STUDY OF COSTA MESA DRIVE/PASTRANA DRIVE BETWEEN LA FONDA DRIVE AND ALICANTE ROAD

Senior Administrative Analyst Rounds introduced the item and said that resident Amador Villanueva submitted a request for a traffic study of Costa Mesa Drive/Pastrana Drive between La Fonda Drive and Alicante Road.

Mr. Rounds introduced the City's Traffic Engineer Irena Guilmette. Traffic Engineer Guilmette studied the location and presented a report on the traffic study. Ms. Guilmette provided information pertaining to the study.

She said the study evaluated speeds, a review of existing traffic controls, and a review of the five-year collision history along Costa Mesa Drive/Pastrana Drive between Alicante Road and La Fonda Drive.

Traffic Engineer Guilmette said that field observations indicated most children from La Pluma Elementary School were picked up and were not walking on Costa Mesa Drive or Pastrana Drive. She said to enhance driver awareness of the speed limit, it was recommended additional "Speed Limit 25" signs with "Radar Enforced" plaques be installed.

Vice Chairman Morfin moved and Commissioner Madison seconded to approve the installation of a northbound "Speed Limit 25" sign with a "Radar Enforced" plaque on the east side of Costa Mesa Drive at the north curb line of Orsa Drive and the installation of a southbound "Speed Limit 25" sign with a "Radar Enforced" plaque on the west side of Costa Mesa Drive at the north curb line of Cartela Drive.
