# 2. PRESENTATION OF FY 2017-18 INTERIM AUDIT INFORMATION BY MOSS, LEVY & HARTZHEIM LLP AUDITORS

Mr. Hartzheim provided an overview of the interim audit conducted in June. He said that during the interim audit the auditors reviewed internal controls and tested financial documents and receipts.

Mr. Hartzheim advised the Audit Committee that the California Department of Finance completed its review of the Oversight Board's actions. Based on its review, the Department of Finance did not approve the enforceable obligation related to the City's loan to the Redevelopment Agency in the amount of \$24,828,264.

Mr. Robertson explained how the \$24,828,264 would be recorded as an extraordinary loss item

in financial reports. He also said a note would be added to emphasize the City was still pursuing the loan amount.
