NEW BUSINESS

6. REQUEST FOR A TRAFFIC STUDY OF BIOLA AVENUE AND GARDENHILL DRIVE

Senior Administrative Analyst Rounds introduced the item and said that a resident requested the installation of rectangular rapid flashing beacons (RRFBs) on Biola Avenue at Gardenhill Drive. Mr. Rounds said that the resident expressed concern with the safety of pedestrians crossing the street at the location. Mr. Rounds reported that the City also received two letters from residents supporting the installation of the RRFB's on Biola Avenue at Gardenhill Drive.

Commissioner Day moved and Chairman Johnson seconded to assign the Traffic Engineer and Commissioner Day to study the location and report their findings at a future meeting.

7. REQUEST TO PROHIBIT STOPPING ON VALLEY VIEW AVENUE AND TROJAN WAY

Senior Administrative Analyst Rounds said the City's Traffic Engineer studied the locations.

Mr. Rounds introduced Public Works Director/City Engineer Mark Stowell.

Mr. Stowell said a recent review of the two-hour parking restriction in the Industrial Area revealed that rescinding and replacing the No Stopping Anytime prohibitions on the east side of Valley View Avenue between Alondra Boulevard and Stage Road as well as on both sides of Trojan Way between Firestone Boulevard North and Alondra Boulevard would be beneficial. He said staff also recommended No Stopping Anytime prohibitions be enacted overall on Valley View Avenue within the City of La Mirada limits between Artesia Boulevard and Imperial Highway.

Commissioner Brasov asked if the affected business owners were contacted about the proposed change to parking.

Commissioner Day mentioned that No Stopping Anytime prohibitions currently exist on Trojan Way due to the detour for the I-5 Freeway construction.

Commissioner Madison asked for clarification on the benefit of prohibiting parking on Valley View Avenue.

Chairman Johnson asked about funding for these changes.

Mr. Rounds said that business owners in the area have called the City to request no parking on the street. He said that the affected business owners were not notified of the proposed change.

Mr. Stowell said that removing the parking on Valley View Avenue would promote uninterrupted traffic flow, and removing the parking on Trojan Way would accommodate two lanes of travel in each direction. He said prohibiting parking on Valley View Avenue is a clean-up item since a new tenant is moving into the building. Mr. Stowell said that only one business would be affected. Mr. Stowell indicated that the costs for these changes would be minimal to the City.

Commissioner Madison moved and Commissioner Brasov seconded to recommended the Public Safety Commission recommend the City Council adopt a resolution authorizing the City to remove the two-hour parking restriction on both sides of Trojan Way between Firestone Boulevard North and Alondra Boulevard; remove the two-hour parking restriction on the east side of Valley View Avenue between Alondra Boulevard and Stage Road; prohibit stopping on both sides of Trojan Way between Firestone Boulevard North and Alondra Boulevard; prohibit stopping on the east side of Valley View Avenue between Artesia Boulevard and Rosecrans Avenue; and prohibit stopping on both sides of Valley View Avenue between Rosecrans Avenue and Imperial Highway contingent on contacting the affected business owners.

STAFF ANNOUNCEMENTS

Senior Administrative Analyst Rounds welcomed Los Angeles County Sherriff's Department Sergeant Busch. Mr. Rounds said that in September, residents had the

opportunity to participate in the Ring Rebate Program. He said \$10,000 of City funding enabled 200 La Mirada residents to participate in the program. He also reported that the My La Mirada service request application system can be used for emergency notifications. Mr. Rounds said that Governor Brown recently signed SB 946 allowing street vending.
