## MINUTES OF THE REGULAR MEETING OF THE LA MIRADA CITY COUNCIL OCTOBER 23, 2018 – 6:30 P.M.

8.5 CAPITAL IMPROVEMENT PROJECT NO. 2017-07, MEDIAN LANDSCAPE IMPROVEMENTS FOR LA MIRADA BOULEVARD FROM LEFFINGWELL ROAD TO ALONDRA BOULEVARD, AND CAPITAL IMPROVEMENT PROJECT NO. 2017-08, MEDIAN LANDSCAPE IMPROVEMENTS FOR ROSECRANS AVENUE FROM VALLEY VIEW AVENUE TO BEACH BOULEVARD – APPROVAL OF PLANS AND SPECIFICATIONS

The City Council found that pursuant to the California Environmental Quality Act of 1970, the project is categorically exempt under Section 15101, Class (C) and will have no significant adverse effect on the environment; approved the plans and specifications for Capital Improvement Project No. 2017-07, Median Landscape Improvements for La Mirada Boulevard from Leffingwell Road to Alondra Boulevard, and Capital Improvement Project No. 2017-08, Median Landscape Improvements for Rosecrans Avenue from Valley View Avenue to Beach Boulevard; and authorized the City Clerk to advertise for sealed bids.

8.6 CAPITAL IMPROVEMENT PROJECT NO. 2017-09, MEDIAN LANDSCAPE IMPROVEMENTS FOR VALLEY VIEW AVENUE FROM IMPERIAL HIGHWAY TO ROSECRANS AVENUE - APPROVAL OF PLANS AND SPECIFICATIONS

The City Council found that pursuant to the California Environmental Quality Act of 1970, the project is categorically exempt under Section 15101, Class (C) and will have no significant adverse effect on the environment; approved the plans and specifications for Capital Improvement Project No. 2017-09, Median Landscape Improvements for Valley View Avenue from Imperial Highway to Rosecrans Avenue; and authorized the City Clerk to advertise for sealed bids.

8.7 LA MIRADA SYMPHONY FUNDING REQUEST FOR FISCAL YEAR 2018-19

The City Council approved the La Mirada Symphony's Fiscal Year 2018-19 funding request in the amount of \$5,000 and an in-kind contribution of \$40,000 for a total of \$45,000.

8.8 PURCHASE OF REPLACEMENT WIRELESS MICROPHONES FOR THE LA MIRADA THEATRE FOR THE PERFORMING ARTS

The City Council approved the purchase of a new wireless microphone system in the amount of \$54,526.45 from Apex Audio.

#### 9. ORDINANCES AND RESOLUTIONS

9.1 RESOLUTION NO. 18-28 AUTHORIZING AND APPROVING THE ADOPTION OF THE PENSION STABLIZATION TRUST AND APPOINTING THE CITY MANAGER AS THE CITY'S PLAN ADMINISTRATOR

City Manager Boynton reported that the City issued a Request for Proposals for Section 115 Pension Trust Administration. He said the City received two proposals, and staff is recommending establishing the trust with Keenan Financial Services. He said Keenan Financial Services would function as the plan administrator, Benefit Trust Company (BTC) as the discretionary trustee, and Morgan Stanley as the Registered Investment Advisor. He said Morgan Stanley would actively manage plan assets consistent with the trust Investment Policy Statement. Mr. Boynton also provided information on the potential benefits of participating in a Section 115 Trust Program that would accumulate, hold, and distribute pension plan assets for the exclusive benefit of retiree pensions.

Councilmember Eng moved and Mayor Pro Tem De Ruse seconded to award the contract to Keenan Financial Services as the Pension Trust Program Administrator and Benefit Trust Company as the Discretionary Trustee with Morgan Stanley as the Registered Investment Advisor; direct the City Attorney to prepare an agreement with Keenan Financial Services for a term of three years with an option to renew for up to five additional one-year periods; adopt Resolution No. 18-28 authorizing and approving the adoption of the Pension Stabilization Trust and appointing the City Manager as the City's Plan Administrator; authorize the City Manager to sign the Pension Stabilization Trust for California Municipalities Participation Agreement with Benefit Trust Company; designate the City Manager as the City's representative to the Pension Stabilization Trust for California Municipalities Board of Authority; and authorize the initial deposit of \$3.5 million to fund the trust with the Moderate Growth as the portfolio model of choice.
