8.6 CAPITAL IMPROVEMENT PROJECT NO. 2018-07, SANTA GERTRUDES AVENUE CORRIDOR TRAFFIC SIGNAL UPGRADES – APPROVAL OF AN AMENDMENT TO THE ON-CALL PROFESSIONAL SERVICES AGREEMENT WITH LIN CONSULTING, INC.

The City Council approved and authorized the City Manager to execute an amendment to the On-Call Professional Services Agreement between the City of La Mirada and LIN Consulting, Inc. to provide professional design services for CIP No. 2018-07, Santa Gertrudes Avenue Corridor Traffic Signal Upgrades, based on the LIN Consulting, Inc. proposal dated October 30, 2018 in the amount of \$47,510; and authorized the City Manager to approve additional professional services to LIN Consulting, Inc., if required, for up to 20 percent of the authorized contract amount.

9. PUBLIC HEARING

9.1 RESOLUTION NO. 18-30 APPROVING AN ADDENDUM TO THE ADOPTED INITIAL STUDY/MITIGATED NEGATIVE DECLARATION FOR THE CITY OF LA MIRADA AQUATICS CENTER AND PUBLIC SAFETY EXPANSION PROJECT

Mayor Mowles opened the Public Hearing.

City Manager Boynton reported that an Initial Study/Mitigated Negative Declaration (IS/MND) for the City's Aquatics Center and Public Safety Facility Expansion Project was prepared by Albert A. Webb Associates and adopted by the City Council on May 23, 2006. He said the City is proposing a new waterpark feature to be added onto the existing Aquatics Center site. The proposed project is within the scope already analyzed for

the Aquatics Center and the proposed construction and implementation of the new water feature is a minor change to the previous California Environmental Quality Act (CEQA) analysis prepared in 2006 for the City's Aquatics Center. He said the City has contracted with Albert A. Webb Associates for the preparation of an addendum to the IS/MND.

Senior Environmental Analyst Stephanie Tang of Albert A. Webb Associates said an analysis of the proposed project determined that onsite improvements associated with the proposed project are all consistent with what is currently operating at the site and would provide a minor change to the existing operations. She said the proposed water slides and lifeguards will comply with the Department of Occupational Safety and Health requirements. She also said there would be no significant environmental impacts to aesthetics, lighting, parking and traffic, noise, and operations.

No members of the public spoke on the item.

Mayor Mowles closed the Public Hearing.
