NEW BUSINESS

2. 2019 HOMELESS COUNT

Aquatics Manager Liza Soto introduced Community Services Coordinator Jorge Orozco.

Community Services Coordinator Orozco reported the City participated in the 2019 Los Angeles Homeless Services Authority's (LAHSA) Homeless Count held January 23. He shared tentative results from predetermined areas canvassed by volunteers and informed the Commission that an accurate estimate of the homeless population in La Mirada would be released by LAHSA, which includes any findings outside of the predetermined areas.

Commissioner Lee inquired about the sharp increase of persons in recreational vehicles and campers between 2017 and 2018.

Community Services Coordinator Orozco responded and stated the restrictions placed by surrounding cities in 2017 prohibiting parking of recreational vehicles on public streets may have caused the increase. He also stated no persons in recreational vehicles were found in this year's homeless count.

Commissioner Savage inquired how homeless persons are identified.

Community Services Coordinator Orozco reported that volunteers attended a training regarding safety and identification markers.

3. COLLEGE BANNER PROGRAM

Aquatics Manager Soto re-introduced Community Services Coordinator Orozco.

Community Services Coordinator Orozco reported on the College Banner Program and said applications would be available to La Mirada High School students in March. He said new banners would be installed in June and that last year's banners would be gifted to the recipients' families.

Vice Chairman Cota inquired about program costs.

Community Services Coordinator Orozco responded and informed the Commission that the banners were \$100 each and provided by the Norwalk- La Mirada Unified School District, while the City covered the installation cost.

Commissioner Lee inquired about the possibility of extending the banner program's location past Adelfa Drive and on to the main cross streets.

Community Services Coordinator Orozco responded and informed the Commission that the light poles located on La Mirada Boulevard and Rosecrans Avenue are utilized for the Military Banner Program and the Avenue of Presidents portraits.

4. VOLUNTEERS IN ACTION QUARTERLY REPORT (OCTOBER - DECEMBER 2018)

Aquatics Manager Soto introduced Community Services Technician Amanda Watson.

Community Services Technician Watson reported a combined total of 48,377 volunteer hours were contributed during the months of October, November and December 2018 through the Volunteers in Action program.

La Mirada resident Lee Olsen reported volunteer hours for the Planning Commission were inaccurately reflected on the supplemental volunteer service hours report.

Community Services Technician Watson responded and stated staff would review the hours and follow up with Mr. Olsen.

SENIOR, HISTORICAL, AND YOUTH COUNCIL REPORTS

Historical Preservation Advisory Council Vice Chairperson Marlene Olsen informed the Commission that tours of the George House would be available during the regularly scheduled Neff Estate Tours while renovations at the Neff Mansion continue. She also stated resident Harry Scott was recently appointed to the Historical Council and reported on several items including the Gardenhill Park Ribbon Cutting Ceremony, Meals on Wheels Spaghetti Dinner, and the AARP Tax Aide Program.

Senior Council Chairperson reported on SeniorNet registration and encouraged increased promotion of workshops and seminars in the La Mirada Living. He reported on the Gardenhill Playground Ribbon Cutting Ceremony, Love a Tree poster contest, and the Senior Safety and Crime Prevention Workshop.

Youth Council Member Benjamin Coronado reported on the annual park review, Father Daughter Dance, and the Father Son Campout.

COMMISSION ANNOUNCEMENTS

Commissioner Gramajo attended the Gardenhill Playground Ribbon Cutting Ceremony, the Meals on Wheels Spaghetti Dinner, and the annual Homeless Count. She stated a La Mirada Kiwanis fundraiser would be held on February 23 at the La Mirada Volunteer Center.

Commissioner Lord responded and recommended that local organizations providing scholarships meet and discuss the selection process.

Vice Chairman Cota commended staff on the Homeless Count, Youth in Government Luncheon, and the Gardenhill Ribbon Cutting Ceremony. She reported on the Meals on Wheels Spaghetti Dinner, the 2019 Relay for Life, and the Mayor's Prayer Breakfast to be held on April 12.

BACKGROUND

Throughout the years, the City of La Mirada continues to partner with local social service agencies that offer pertinent programs and services to La Mirada residents. Many of the social service agencies listed in this report continue to provide various services to the La Mirada community.

FINDINGS

Social services agencies that have received funding in previous years are sent a funding application packet. The application includes information on the agency and services provided. As part of the application process, agencies are required to submit current insurance documents, the most recent copy of an independent audit, independent review, or California Exempt Organization Annual Statement (Form 199). The City's Finance and Risk Management departments review the insurance documents and financial reports provided by the agencies and ensure the proper information is received prior to the funding. The City's policy regarding funding remains as follows: funding in the amount of \$5,000 and under may be approved by the City Manager; amounts over \$5,000 are presented to the City Council for approval.

The funding process begins with the Community Services Commission which conducts site visits to each agency, provide an evaluation and recommendation, and hear from the agency representative during a Commission meeting. Information regarding past funding amounts and amounts requested are shown on Attachment A. During Fiscal Year 2017-2018 and Fiscal Year 2018-2019 the Commission recommended funding of \$108,381.

At tonight's meeting Commissioners will select agencies to evaluate as well as hear from the following agency representatives. It is requested that Commissioners complete the site visits and evaluations by March 27.
