7.5 CAPITAL IMPROVEMENT PROJECT NO. 2017-03, MEASURE I, PHASE 5, RESIDENTIAL STREET REHABILITATION – REVIEW OF BIDS AND AWARD OF CONTRACT

The City Council awarded the contract for Capital Improvement Project No. 2017-03, Measure I, Phase 5, Residential Street Rehabilitation, to R.J. Noble Company in the amount of \$7,932,019; authorized the City Manager to execute the contract on behalf of the City; authorized the City Manager to approve addendums to the existing on-call engineering contracts for construction support services in an amount not to exceed ten percent of the construction cost; and authorized the City Manager to approve additional work up to 20 percent of the total project cost including construction and construction survey, testing and inspection.

7.6 AGREEMENT WITH THEATER DIRECT, INC. FOR TELEMARKETING SERVICES FOR THE LA MIRADA THEATRE FOR THE PERFORMING ARTS The City Council approved a professional services agreement with Theater Direct, Inc. for telemarketing services for the La Mirada Theatre for the Performing Arts and authorized the City Manager to execute the agreement on behalf of the City.

7.7 LANDSCAPE MAINTENANCE SERVICES FOR PARKS AND FACILITIES – REVIEW OF PROPOSALS AND AWARD OF CONTRACT

The City Council awarded the contract to So Cal Land Maintenance, Inc. for landscape maintenance services for parks and facilities and authorized the City Manager to execute the contract and any required extensions to the contract on behalf of the City.

- 8. ORDINANCES AND RESOLUTIONS
 - 8.1 SECOND READING AND ADOPTION OF ORDINANCE NO. 706 AMENDING REGULATIONS APPLICABLE TO DANGEROUS FIREWORKS, AND AMENDING TITLE 16 OF THE LA MIRADA MUNICIPAL CODE

City Manager Boynton said the proposed ordinance would allow the City to issue administrative citations to persons who allow dangerous/illegal fireworks to be discharged on or from property that is owned, leased, rented, or otherwise lawfully possessed by them. He said the ordinance was introduced for first reading at the January 22 City Council meeting.

Councilmember Lewis moved and Councilmember Eng seconded to accept for second reading and adopt Ordinance No. 706 amending regulations applicable to dangerous fireworks and amending Title 16 of the La Mirada Municipal Code, by title only, and waive further reading.

8.2 FIRST READING OF ORDINANCE NO. 707 ADDING A NEW CHAPTER 4.70 TO THE LA MIRADA MUNICIPAL CODE TO CREATE A SIDEWALK VENDING PROGRAM

City Attorney James Markman reported that a substantive change was made to Ordinance No. 707 that was introduced for first reading at a prior meeting. He said the original ordinance that was presented at the meeting required sidewalk vendors to provide a clearance of not less than three feet on all sidewalks or pedestrian areas. He said legal authority supports a four foot clearance which is a more appropriate standard. He said the ordinance has been modified to include the four foot clearance requirement. He said that since Ordinance No. 707 was modified, the ordinance needs to be reintroduced for first reading.

Councilmember Sarega moved and Councilmember Lewis seconded to introduce for first reading Ordinance No. 707 adding a new Chapter 4.70 to the La Mirada Municipal Code to create a sidewalk vending program, by title only, and waive further reading.

9.2 RESOLUTION NO. 19-04 ESTABLISHING A FEE FOR A SIDEWALK VENDING PERMIT

He said staff conducted an analysis in order to determine the costs to the City in processing applications for sidewalk vending permits. Based on the analysis, staff recommends a \$110 annual fee be established. He said the proposed fee would be no greater than the minimum cost to the City to process an application. Mr. Boynton also reported that the City received a letter from a member of the public regarding sidewalk vending.
