RENOVATIONS AT STATER BROS. SHOPPING CENTER



The Stater Bros. shopping center, located on the southeast corner of La Mirada Boulevard and Imperial Highway, is in the process of completing exterior renovations. The shopping center began building improvements about four years ago and the work has achieved a more uniform appearance for all the separate buildings.

Enhancements to the shopping center, which is anchored by the Stater Bros. supermarket, includes upgrades to building façades and new signage to better identify the mix of retailers. CALIFORNIA CITIES REQUIRED TO ALLOW SIDEWALK VENDING

In September of 2018, former Governor Brown signed into law Senate Bill (SB) 946, legalizing sidewalk vending statewide. Outright local bans on sidewalk vending are prohibited. Cities only have a limited ability to restrict vending when it affects the public's health, safety, and welfare.

Prior to the passage of SB 946, sidewalk vending was prohibited in La Mirada. The City of La Mirada recently passed an ordinance regulating sidewalk vending and established a permit process. Vendors are subject to specific regulations, including strict hours of operation.

Sidewalk vending in commercial areas is only permitted during the hours of operation of other businesses or uses on the same street. Vending carts cannot become permanent fixtures on the vending site or be considered an improvement to real property. Sidewalk vendors are also required to pick up, remove, and dispose of all trash within a 15-foot radius of the vending location. Violations of the new law may result in administrative fines of up to \$1,000.
