### SOLID STATE DEVICES RECOGNIZED AS "GOOD CORPORATE CITIZEN"



The Los Angeles County Sanitation Districts have a special "Certificate of Recognition" program that honors industries that have been in full compliance with all Sanitation Districts' industrial waste requirements.

"This recognition program proves that industry and local government can work cooperatively to protect public health and the environment in a business-friendly way," says Linda Shadler, Head of the Sanitation Districts' Industrial Waste Section.

The Sanitation Districts recently recognized companies with certificates for being "good corporate citizens" for the year 2020. Solid State Devices Inc. (SSDI), located in La Mirada, was recognized for meeting limits for wastewater discharge, maintaining environmental equipment, and fulfilling all permit requirements for 13 consecutive years. SSDI is one of 82 companies that has received this recognition for five or more consecutive years.

### LA MIRADA NAMED AMONG CITIES WITH LOW FINANCIAL RISK



La Mirada placed in the top six percent of financially sound cities in California according to a recent assessment by State Auditor Elaine Howle. La Mirada continues to have low risk for major fiscal challenges based on the auditor's criteria.

The City scored well in categories including general fund reserves, debt burden, liquidity, pension obligations, pension costs, future pension costs, post-employment benefits obligations, and post-employment benefits funding. The information was gathered from the Fiscal Year 2019-2020, which is the most recent complete year of financial reports available.

"Being good stewards of the public's resource, has been characteristic of La Mirada for many years," says City Manager Jeff Boynton. "Having healthy finances ensures the City will be able to continue providing quality services and programs for our residents and business community."
