PUBLIC HEALTH AND SAFETY ACKNOWLEGEMENT

CONDITIONAL TUP: [insert TUP title]

The City's issuance of a temporary use permit (TUP) is based, in part, on local conditions affecting public health and safety, such as the current Covid 19 pandemic, as they exist at the time of the TUP application, and as they are expected to exist at the time of the TUP event. The City takes into consideration health orders and guidelines issued by the City Council, County of Los Angeles Health Department, the State, and/or federal government (collectively, "Health Regulations"). Therefore, THIS TUP IS CONDITIONAL. It is issued in anticipation of the TUP event being allowed under the Health Regulations in effect at the time of the TUP event. If, however, due to a change in local conditions at the time of the TUP event, the Health Regulations do not allow the TUP event to safely and lawfully be conducted, as determined by the City, then the City may rescind the TUP immediately upon providing notice to the applicant, and the applicant may be asked to postpone or cancel the event in the interest of public health and safety. By accepting the terms of this TUP, the applicant agrees to hold the City and its elected officials, officers, employees, and agents, free and harmless, and to release each of them, from any and all claims and liabilities arising out of the City's rescission of the TUP and/or cancellation of the TUP event as described herein.
