## I-5 FREEWAY CONSTRUCTION NEARS COMPLETION

After several years of construction, Caltrans is nearing completion of I-5 improvements in La Mirada. The Valley View Avenue Bridge has recently opened three lanes of traffic in each direction. Four all-purpose lanes and one carpool lane opened in each direction from the Orange County line to south of Florence Avenue during the summer.

The new Valley View Avenue loop off ramp from the northbound I-5 opened in June and the old ramp is closed for demolition. Caltrans recently began pouring the final layer of concrete for the new auxiliary lanes near the new off ramp.
