#### 2. SENIOR COMMUNITY EVENTS UPDATE

Member McCollum reported resident activities were not being offered at Vista Alicante.

Alternate Member Chimberoff reported on new resident activities at Somerset Glen, including Bingo on Fridays.

Member Mary Hall reported on activities held at La Mirada Lake Park, including the Independence Day parade on July 4.

Chairperson Viayra reported on activities held at Breezewood Village. She said Breezewood Village was participating in The Big Give program.

Member Roman reported on activities held at La Mirada Landmark.

Member Rosholt said he attended the Veterans Discussion Group's meeting with Congresswoman Linda Sanchez on July 7 and the All That Dance event on July 22. He reported on the La Mirada Gadabouts and its meetings on the third Wednesday of every month at 1 p.m. at the Activity Center. Member Rosholt reported on the rise of text messaging scams targeting seniors. He discussed ways to recognize fake text messages that mislead seniors into providing personal information.

Vice Chairperson Torres reported on the Veterans Discussion Group's meeting with Congresswoman Linda Sanchez on July 7 and said it was well attended. He said the Veterans Discussion Group meeting on August 4 would feature guest speakers Marty Schaefer and Fred Zermeno. He said Ed Choi would attend the Veterans Discussion Meeting in September to highlight the Birdwell Foundation. Member Torres reported on the Veterans Coordinating Council's collaboration with the City for the Salute to Veterans event on November 7.

Member Rosholt commented that the Veterans Discussion Group is open to all community members. He reported on the importance of the Birdwell Foundation and said the organization offers support and resources for veterans and first responders suffering from post-traumatic stress disorder and traumatic brain injuries.

#### **NEW BUSINESS**

#### 4. ACTIVITY CENTER FALL EVENTS AND PROGRAMS UPDATE

Community Services Supervisor Montoya reported on the Activity Center's fall programs and events. She highlighted the All That Dance event on September 9, the Community Health Information and Safety Fair on September 14, and the Fall Festival on October 13.

Members discussed the All That Dance event held in celebration of Parks and Recreation Month on July 22. Members provided positive feedback regarding the event and said attendees enjoyed the ice cream social component and live entertainment by DJ Professor D. Members commented that the schedule change from 7 to 10 p.m. to 2 to 5 p.m. allows for more seniors to attend the event and utilize the City's transit services.

Community Services Supervisor Montoya thanked Members for their feedback. She said the Senior Council would be given the opportunity at the next meeting to make recommendations regarding the All That Dance event on September 9.

She said the Southeast Area Social Services Funding Authority has strict regulations regarding the Café on the Green program. She said the City works alongside Interfaith Food Center in providing food items for those in need of assistance. Mrs. Montoya said she would provide the contact information for Interfaith Food Center to the Café on the Green Manager.
